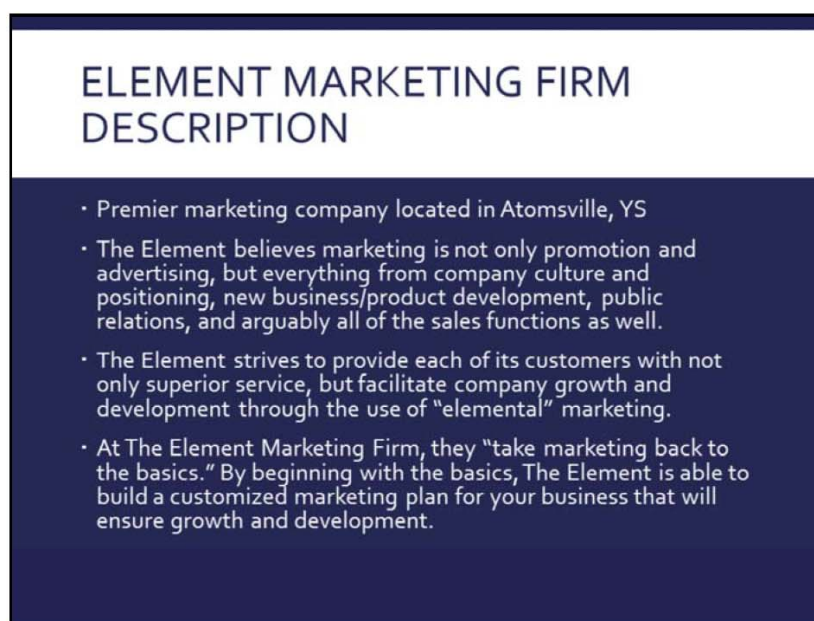
Directions:
